7. **Essential service preferences:** HPC staff that is experienced with more medically involved individuals. He requires full assistance for all ADL's and iADL's.
8. **Additional Information:** He is non-verbal, unable to read or write. He is able to express his likes and dislikes to those who know him well. He will smile when being talked to or played with and stops crying when comforted. He engages in back and forth simple games and making sounds. He likes music and playing his guitar
 - **Supervision Level:** He needs constant supervision
 - **Medical/Medication/Health:** medication management, seizure management He has a shunt that is programmable; he cannot be around strong magnets. He has many seizures throughout the day and is monitored closely and provided with supports of Diastat and oxygen when needed.

 - **Hygiene/ADL/Personal Care:** Bathing, dressing, total personal care, walk in bathtub
 - **Mealtime/Cooking/Household Maintenance:** Assist with changing his bed and keeping his room and bathroom clean. Prepare meals and follow feeding protocols.
